A MESSAGE FROM 2023 BOARD PRESIDENT KAYLA MACEWEN



Our 27th year was one of diligence from the Board. We started the year establishing some crucial initiatives that included our Issuer Ambassador program, member value proposition, and a personnel review that evaluated the work balance of the Board and our third-party vendors.

We were able to assemble a value proposition in time to kick off our Issuer Ambassador Program. This proposition outlined the benefits of being a member of Women in Public Finance. Some of those advantages were networking, community, business development, leadership, education, mentorship, recruiting, scholarship, and chapter participation.

The Issuer Ambassador Program gave chapters the opportunity to send an issuer to our Annual Conference with a subsidy from the national organization if they were able recruit 10 of their affiliates to become members of the organization. At the conclusion of the membership drives, 13 chapters were able to send someone to the conference. We also took the opportunity to engage with the Issuer Ambassadors after the conference to gather feedback on their experience. We are excited to continue the program in 2024 with some slight improvements with credit to the chapters for their feedback. Stay tuned!!!!

Our personnel initiative was another step in securing the continuity of the organization. We reviewed our current Board Member tasks, as well as those of our third-party vendors, to create more capacity for Board Members to focus on strategic planning. As a result, we expanded our contract with the Municipal Advisory Council of Texas. We also reviewed the current bylaws for necessary updates. Included in this update was the inclusion of a President Elect position to help with the transition of the President position each year.

In 2023 we were excited to add a new chapter in Pennsylvania and are just shy of 1,000 members. We had an amazing conference in Washington, DC with over 500 people in attendance. Our Mentorship and Scholarship programs continue to thrive and grow.

Thank you to the current Board for all your hard work this year. I also am very thankful to our members, sponsors, and our chapters. Without you all this organization would not exist and continue to grow.

WPF began as a Chicago based organization and has grown over these decades to 23 regional chapters, ultimately drawing interest and participation from all over the United States. WPF is national membership organization with chapters, individual members, and affiliates throughout the United States. Our values are grounded in leadership development to advance women in public finance through mentoring, educational and scholarship programs and relationship building. Members in the organization represent many facets of the industry including state and local government issuers, investment bankers, commercial bankers, attorneys, financial advisors, rating agency analysts, bond insurers, and trust officers, among others. 
2023 HIGHLIGHTS

FINANCIALS

WPF derives its income from sponsorships, conference registrations and membership dues. The impact of our sponsors is incredible and is hugely important to WPF's mission, accounting for over 70% of total income. Over 60% of our annual budget is spent on expenses related to our Annual Conference, which underscores the importance of the Annual Conference in furthering WPF's mission. WPF's net income has increased by approximately 20% to \$112,108. WPF continues to focus on identifying ways to increase revenues and manage expenses. MEMBERSHIP

Women in Public Finance saw the most growth ever in 2023, adding 488 new members since the start of the year and ending with a total of 985 dues-paying members, a 44% increase in membership compared to 2022. We are excited to welcome our 1,000th member in 2024.

The Issuer Ambassador Program that launched in Spring 2023 helped drive membership by engaging WPF's chapters to actively recruit new members. 164 new members were added from May 1, 2023 to July 1, 2023, representing 33% of total new members joining in those two months. The Issuer Ambassador Program will be updated and launched again in 2024, and we are striving for continued growth in membership.

SCHOLARSHIP

To encourage young women to consider careers in public finance, the Scholarship Committee recognizes college-bound high school students and both undergraduate and graduate school students who have exhibited scholastic achievement and demonstrated leadership skills by awarding scholarships. In addition to the opportunity for an award, scholarship recipients are afforded the opportunity to meet established women in the public finance industry and learn about career options. In 2023, 5 national scholarships – totaling \$15,000 – were granted to the aspiring public finance female professionals noted below.

EDUCATION

The Education Committee supports the organization's mission by providing educational opportunities and resources designed to advance the careers of women in the public finance industry. By developing, facilitating, and promoting educational offerings, members enhance their knowledge of the industry, develop unique skillsets and hone leadership skills. In 2023, WPF hosted webinars on leadership and professional development training. Our webinars included:

- WPF Book Club featuring Marina Scott, municipal issuer and historical fiction writer, author of *The Hunger Between Us*.
- Mahara Mindfulness Wellness Workshop Self-care through mindfulness practices designed to promote wellness.
- Pathways to Power: Public Service Through Regulation Exploration of leadership with female leaders from organizations including the CFPB, FINRA, MSRB and SEC.

MENTORSHIP

Mentorship is one of the most important tools for professional development and has been linked to greater productivity, career advancement, and professional satisfaction. WPF recognizes that mentorship is critical in helping to nurture and grow future leaders, maintain current industry leaders, and provide an opportunity for current members to remain engaged. The mentorship program launched in 2019 and continues to provide opportunities for women to grown and learn from each other. The number of WPF members supported by the Mentorship Committee has perpetually grown, with 32 pairs in 2023.





CHAPTERS

Women in Public Finance's 23 chapters were active in connecting the public finance community across the country in 2023. Chapter events included hands-on experiences of public infrastructure with airport tours at several major airports, "Women & Whiskey" and "Flannels & Finance" networking gatherings, and even a private showing of the *Barbie* movie. Chapters were active in their communities, offering financial literacy education to local K-12 students, preparing meals at a food bank, and collaborating with other industry organizations to expand their reach. Ladies First became the Pennsylvania chapter of Women in Public Finance, and we are potentially adding two additional chapters by the end of 2024. The chapters were very active in launching WPF's Issuer Ambassador program, with 13 chapters sending Issuer Ambassadors to the 2023 conference.

ISSUER AMBASSADOR PROGRAM

In 2023, WPF kicked off its inaugural Issuer Ambassador Program. A membership drive was launched in early 2023 – chapters that were able to recruit at least 10 affiliates to become WPF members were provided with a subsidy for an Issuer Ambassador to attend the 27th Annual Conference. The program was highly effective, and in part served as the catalyst for the year-over-year increase in membership detailed herein. KEYNOTE SPEAKERS

Mayor Muriel Bowser welcomed WPF and conference attendees to Washington, DC. As the seventh elected mayor of Washington, DC, she has a strong record of creating a bold urban policy agenda, making tough decisions in a high stakes environment, and shaping a diverse economy. Mayor Bowser has served her hometown in elected office since 2004 as Advisory Neighborhood Commissioner (2004-2006), Member of the DC Council (2007-2015) and now Mayor since 2015.



LIFETIME ACHIEVMENT AWARD



Treasurer Deborah B. Goldberg is the Treasurer and Receiver General of the Commonwealth of Massachusetts. In that role, she is responsible for the state's cash and debt management, unclaimed property, and chairs state boards and commissions, including the Massachusetts School Building Authority, the Pension Reserves Investment Management Board, the State Board of Retirement, Massachusetts State Lottery Commission, and the Massachusetts Clean Water Trust. In 2015, she established the new Office of Economic Empowerment, the first of its kind in the country, and chairs its Economic Empowerment Trust Fund. Treasurer Goldberg is the former President of the National Association of State Treasurers and is the Co-Chair of the National Institute of Public Finance.

As a former businesswoman and local elected leader, Treasurer Goldberg brings innovative leadership, disciplined fiscal management and an unwavering commitment to uphold economic stability and create opportunity for every Massachusetts resident. Treasurer Goldberg served for six years on the Brookline Board of Selectmen, including two as its Chair. Prior to her career in public service, she worked in retail operations, buying, and consumer affairs at The Stop & Shop Companies, Inc.

Treasurer Goldberg is the President Emeritus of Adoptions with Love and serves on the Advisory Board of the Greater Boston Food Bank. She was one of the founders of Berkshire Hills Music Academy, a school for individuals with intellectual disabilities, is a trustee emeritus at Beth Israel Lahey Health, and a former Director at Affiliated Physicians Group / Beth Israel Deaconess HealthCare. Treasurer Goldberg has been actively involved with numerous philanthropic activities, including The Grow Clinic, the 100 Club, Planned Parenthood League of Massachusetts, and the Combined Jewish Philanthropies.

A graduate of Boston University, Boston College Law School and Harvard Business School, Treasurer Goldberg lives in Brookline with her husband Michael Winter. She has a son, Evan, and daughter, Meredith.


University of Southern California in 2019 after transferring from Pasadena City College.
